- Rural Digital Opportunity Fund (RDOF)
- NC Growing Rural Economies with Access to Technology (NC GREAT) Grant Program





Rural Digital Opportunity Fund (RDOF)

- FCC Program awards determined through reverse auction
- \$16.9M Award to Charter/Spectrum
- 11,128 locations awarded in Jackson County
- 6-year total project timeframe

NC GREAT Grant

- NC Program managed through NCDIT Office
- Jackson County had 2 awards
 - 1,156 locations awarded to Charter/Spectrum \$4,497,486
 - 636 locations awarded to Balsam West \$2,431,130.90
- 2 year total project timeframe






Charter/Spectrum Progress Update

- RDOF 1,223 Addresses Activated
- NC GREAT 330 Addresses Activated
- They reported some initial delays with permitting but are back on track.
- RDOF Completion projected by 1Q28


- Blue = RDOF Award Addresses

Completing Access to Broadband (CAB) Grant Program


- Program kickoff by NCDIT in January 2024
- County collaborates with NCDIT to identify project area and scope
- Project is posted on NCDIT website as an RFP
- Qualified providers respond and compete for project
- County reviews responses with NCDIT and selects provider
- Max of \$8M grant per county per year
- CAB represents a potential opportunity to advance projects not funded in the current round of GREAT grants


JACKSON COUNTY CAB ELIGIBILITY

FCC Reported Unserved & Underserved Locations***

Count of Unserved/Underserved Percent Unserved/Underserved



***Unserved & Underserved Locations from the FCC Broadband Data Collection have been aggregated into hexagon-shaped bins to show both the count and percent of unserved & underserved locations within each bin. Locations that have had funds obligated through previous Federal, State or Local broadband expansion programs have been removed from the hexagonal aggregations and county estimates. Darker shades of pink indicate higher total count of unserved & underserved locations. Darker shades of blue indicate a higher percentage of locations within a bin are unserved & underserved locations. Darker shades of purple indicate both a higher total of unserved & underserved locations locations and a higher percentage of total locations within a bin are unserved & underserved locations .

Unserved locations for American Rescue Plan Act (ARPA) funded programs in NC are defined as locations without access to fixed terrestrial internet service, through Fiber, Cable, or non-mobile Licensed Fixed Wireless technologies, of at least 25mb/s Download and 3mb/s Upload speeds. Underserved locations are defined as locations without access to fixed terrestrial internet service of at least 100mb/s Download and 20mb/s Upload speeds, but greater than 25mb/s Download and 3mb/s Upload speeds.


