#### A little bit about your VSO...

- I have 9 family members who are Veterans and my father is a Marine.
- I am a State and National Certified Veteran Service Officer.
- ▶ I have been with the Jackson County VA Office for almost 14 years.
- ▶ I am a Blue Ridge Honor Flight Ambassador Guardian.
- I received a Program graduation in 2018 from the Veteran Support Specialist Program in Psychology from the Duke University School of Medicine.
- ▶ I hold 7 accreditations in 7 different military organizations with the General Counsel in Washington, D.C.
- I am one of 5 VSO's in the 7 western counties that has a cross-accreditation with the North Carolina Division of Military and Veterans Affairs and Veteran of Foreign Wars.
- As of November 2022 I conduct my own veteran appeals in my office through zoom and teleconference. I work one on one with a VA Law Judge to help him/her in deciding Veterans claims decisions to see if I can get the Veterans claims overturned
- My claims success rate is around 91%.

### VA and Jackson County?

- We are the Veterans Benefits Administration NOT the Veterans Health Administration although we help apply for the Healthcare Benefits as well.
- We are employed and paid by Jackson County.
- We are legal representatives (POA's) and Certified Veteran Service Officer's for the U.S. Department of Military and Veterans Affairs and the North Carolina Division of Veterans Affairs.
- We attend (2) week long conferences a year, quarterly state regional trainings, monthly VSO's meetings, and online courses regulated and issued by the U.S. Department of Military and Veterans Affairs to maintain our certifications.
- We have legal trainings and school through National Veterans Legal Service Program for our legal trainings.
- We also have to be trained and knowledgeable with the Federal Veterans Laws, Rules, and Regulations Book and the Veterans Benefits Manuel 38CFR.
- The Veteran's can also utilize a Veteran Service Officer as a go between with the Veteran's Health Administration in case of conflicts with appointments, doctor changes, advocacy, pharmacy, enrollment, etc.




### Jackson County Veterans Office Mission

- The purpose of our office is to help assist in helping the Veterans get healthcare and additional compensation from service related disabilities or a pension to help with Aid and Attendance and to help with additional resources if our office can not provide a specific service.




### Services and Benefits



The Veteran's Service Office administers the laws of the U.S. Department of Veterans Affairs to include:

- Compensation for service connected disability
- Pension for non-service connected veterans
- Headstones/Markers, Burial Flags, Presidential Memorial Certificates, Medals and Military Service Records, Help arrange military grave site rights, Burial Reimbursement, Burial in a National Veteran's Cemetery
- Vocational Rehabilitation, Education, Training
- VA Home Loans
- Housebound Status and Nursing Home Care
   Aid and Attendance.



### Service and Benefits continued

- Healthcare and dental care
- Special housing and automobile adaptation
- ► Fiduciary/Guardianship protection programs
- Homeless
- Mental healthcare
- License Plates, Property Tax Exclusions for those who qualify, Hunting and Fishing License, etc.





- The Veteran can submit the request or you can submit the request on behalf of the Veteran.
- They are awarded a \$2500.00 check and they are able to use the money as long as it goes to their last wish.



### Productivity of the Office



- We see several Veterans a day either who have an appointment, walk-in or they are sent by referral. This does not include the veterans we communicate with by phone, email, fax or event that reside in Jackson County. We see 7-9 new Veterans each week.
- On an average one claim can consist of 5 or more disabilities for one veteran which is service connected. When they are awarded the disability can range from 10% to 100%. The rates are different for a Non-Service Connected Pension based on Nursing fees and Housebound Status which can be greater.
- When the Veteran is awarded depending on his/her combined rating with spouse and children, he/she can draw from \$171.00 to \$4500.00 each month. These monies are tax-free.
- Burial reimbursements can range from \$300-\$2,000, HISA Grants are \$6800 per grant, for home renovations and \$21,000 for an Adaptive Vehicle. These are paid out (once) in a lifetime to the Veteran.

### Revenue from the Jackson County Veterans Office from Compensation and Pension Claims.



- There is approximately 800 disabilities awarded each month in Jackson County.
- ▶ Of those disabilities, \$931,049.37 a month is awarded in Compensation and Pension claims that go back into Jackson counties economy which is tax free money.
- ► For the year 2024 to present my office produced 13.5 million dollars according to the U.S. Department of Veterans Affairs Census and the North Carolina Division of Veterans Affairs.

A lot of people ask... What do the Dependents Qualify For?

Did you know that a Widow's/Survivor's Benefit is the least applied for within the VA?

A Widow/Survivor will automatically qualify for a <u>DIC</u> (Death and Indemnity Compensation) when the Veteran dies of a Service-Connected Death. The DIC is always a flat rate of pay.

A Widow's/Survivor Pension is income and asset based and at least 5% of their income must be medical expenses.

If the Veteran is 100% Service-Connected, the Spouse can apply for CHAMPA Supplemental Insurance under the Veteran.

Children of Veteran may apply for Educational Benefits and Scholarships through the VA. The veteran's qualifying criteria must have occurred during a period of war. The Sergeant First Class (SFC) Health Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act of 2022 which extends additional presumptive illnesses to Agent Orange, Gulf War, and Iraq and Afghanistan Veterans. The Iraq/Afghanistan list will fall under the presumptive of the Gulf War Veterans.

## VETERANS HEALTHCARE THROUGH COMMUNTIY CARE

The Community Care Program replaced the Veterans Choice Program. The benefits for this program are for those Veteran's who are enrolled in VA Healthcare.

Community Care is utilized for a Veteran if he/she has been waiting for an appointment in VA Healthcare for more than 30 days, lives more than 40 miles from the nearest VA Hospital or Clinic, or the Veteran is needing a service that VA Healthcare cannot provide.

An added bonus is if the Veteran is having an emergency and he/she can't drive all the way to the VA Hospital. The 72 Hour Assistance Program allows the Veteran flexibility in seeking medical care for an emergency to utilize local emergency departments. This service is activated by the Veteran or family member notifying the 72 Hour Assistance Program of the emergency incident which allows the VA Healthcare System to pay the bill.
