RE: UDO Technical Corrections- Recreational Uses, Governmental

Planning Staff has been working with the US 441 Planning Council and the Cullowhee Planning Councils to make technical corrections to the use tables in these districts to make clear that governmental recreational uses are allowed in Rural Living district in the US 441 district and the Single Family Residential and Single Family- Manufactured Home districts in Cullowhee. While some recreational uses are allowed in some of these districts, it is not clear that all of the recreation plans the County has for facilities in these areas would be allowed. These corrections would clarify that governmental recreational uses are allowed within these residential areas. The proposed changes are consistent with the both the Parks and Recreation Master Plan, the Jackson County 2040 Land Use Plan, and the Cullowhee Small Area Plan

Both Councils are holding public hearings this week to review the proposed changes to the use tables. The Planning Board will also have to review the proposed changes and make a recommendation. After that, Staff will request that the Board of Commissioners schedule a public hearing for the purposes of considering the proposed amendments.
